Provides control of all diseases controlled by DELARO COMPLETE alone

### plus:

For suppression of fusarium and gibberella ear rots (Fusarium spp. and Gibberella spp.)

For suppression of stalk rots (Fusarium spp., Gibberella spp. and Colletotrichum spp.) which may cause stalk lodging

Apply DELARO COMPLETE at 586 mL/ha in tank-mix with Proline 480 SC Foliar Fungicide at 202 mL/ha.

**DO NOT** apply this tank-mix with an adjuvant.

Do not apply more than 1 application of DELARO COMPLETE per crop year, when tank-mixed with Proline 480 SC Foliar Fungicide.

<u>Timing of application is critical</u>: For optimum suppression of fusarium and gibberella ear rots, apply the tank-mix of DELARO COMPLETE plus Proline 480 SC Foliar Fungicide from the development stage of corn between the tip of stigmata visible (silking, BBCH 63) to the stigmata drying (silk browning, BBCH 67). The tank-mix of DELARO COMPLETE plus Proline 480 SC Foliar Fungicide will reduce both disease symptoms and levels of mycotoxin in the grain.

Fusarium and gibberella ear rots outbreaks in corn occur when the weather is warm and wet during silking. It is also driven by hybrid selection and field history of severe fusarium outbreaks. The application of this tank-mix for protection against fusarium and gibberella ear rots should be considered when these conditions are forecasted for a specific corn field. Applications of this tank-mix timed for suppression of fusarium and gibberella ear rots may also reduce lodging caused by stalk rot pathogens.

# Section 9: APPLICATION INFORMATION AND PRECAUTIONS

### 9.1 Additional Environmental Precautions:

- As this product is not registered for the control of pests in aquatic systems, DO NOT use to control aquatic pests.
- **DO NOT** contaminate irrigation or drinking water supplies or aquatic habitats by cleaning of equipment or disposal of wastes.

# 9.2 Ground and Aerial Application:

### **GROUND APPLICATION:**

<u>Field sprayer application:</u> **DO NOT** apply during periods of dead calm. Avoid application of this product when winds are gusty. **DO NOT** apply with spray droplets smaller than the American Society of Agricultural Engineers (ASAE S572.1) medium classification. Boom height must be 60 cm or less above the crop or ground.

- 1. Use well-maintained and calibrated conventional spray equipment, which provides adequate and uniform coverage.
- 2. Apply DELARO COMPLETE in a minimum of 100 L water/ha.
- 3. Spray screens should be no finer than 50 mesh.
- 4. Ensure that the by-pass line discharges at the bottom of the tank to minimize foaming.
- 5. Maintain pressure at no less than 275 kPa to ensure good foliage penetration and coverage.
- 6. Provincial buffer zones that are greater than the buffer zones indicated in the DIRECTIONS FOR USE, Section 9.3, should be respected.
- 7. If spray mixture remains in the tank overnight, or for long periods during the day, agitate thoroughly prior to application.

### **AERIAL APPLICATION-GENERAL INFORMATION:**

<u>Aerial application:</u> **DO NOT** apply during periods of dead calm. Avoid application of this product when winds are gusty. **DO NOT** apply when wind speed is greater than 16 km/h at flying height at the site of application. **DO NOT** apply with spray droplets smaller than the American Society of Agricultural Engineers (ASAE S572.1) medium classification. Reduce drift caused by turbulent wingtip vortices. Nozzle distribution along the spray boom length MUST NOT exceed 65% of the wing- or rotorspan.

1. Apply only by fixed-wing or rotary aircraft equipment which has been functionally and operationally calibrated for the atmospheric conditions of the area and the application rates and conditions of this label.

- 2. Label rates, conditions and precautions are product specific. Read and understand the entire label before opening this product. - 3. Ensure uniform application. To avoid streaked, uneven or overlapped application, use appropriate marking technology. GPS based marking is preferred.
- 4. Apply DELARO COMPLETE in a minimum of 50 L of water/ha.
- 5. To ensure proper coverage and distribution and to minimize drift, check to see that swath width and droplet size are adequate, and that wind velocities are low.

### **AERIAL APPLICATION-USE PRECAUTIONS:**

- 1. Apply only when meteorological conditions at the treatment site allow for complete and even crop coverage.
- 2. Apply only under conditions of good practice specific to aerial application as outlined in the *National Aerial Pesticide Application Manual*, developed by the Federal/Provincial/Territorial committee on Pest management and Pesticides.

### **AERIAL APPLICATION- OPERATOR PRECAUTIONS:**

- 1. **Aerial applicators:** Wear a long-sleeved shirt, long pants, chemical-resistant gloves, socks and shoes during application. Gloves are not required during application within a closed cockpit. Do not allow the pilot to mix chemicals to be loaded onto the aircraft. Loading of premixed chemicals with a closed system is permitted.
- 2. It is desirable that the pilot has communication capabilities at each treatment site at the time of application.
- 3. The field crew and the mixer/loaders: wear long-sleeved shirt, long pants, chemical-resistant gloves, goggles or a face shield, socks and boots during mixing, loading, clean-up and repair.
- 4. All personnel on the job site must wash hands and face thoroughly before eating and drinking.
- 5. Protective clothing, aircraft cockpit and vehicle cabs must be decontaminated regularly.

# 9.3 Buffer zones:

Spot treatments using hand-held equipment do not require a spray buffer zone.

The spray buffer zones specified in the table below are required between the point of direct application and the closest downwind edge of sensitive terrestrial habitats (such as grasslands, forested areas, shelter belts, woodlots, hedgerows, riparian areas and shrublands), sensitive freshwater habitats (such as lakes, rivers, sloughs, ponds, prairie potholes, creeks, marshes, streams, reservoirs and wetlands) and estuarine/marine habitats.

# 9.4 Rotational Crops:

Treated areas may be replanted with any crop specified on this label and dry beans, dry peas, chickpeas, guar, lentils, peanuts, cucurbit vegetables, sugarbeets as soon as practical after the last application. For all other crops, do not plant back within 30 days of last application.

### **SECTION 11: MIXING INSTRUCTIONS**

DELARO COMPLETE must be applied with properly calibrated, clean equipment. Prior to adding DELARO COMPLETE to the spray tank, ensure that the spray tank is thoroughly clean.

# DELARO COMPLETE applied alone:

- Add one-half of the required amount of water to the spray or mixing tank and start agitation.
- Add the required quantity of DELARO COMPLETE to the water and complete filling with water to the required total volume.
- Maintain agitation throughout mixing and spraying.
- Soybean and Winter wheat: DELARO COMPLETE should be thoroughly dispersed prior to the addition of a non-ionic surfactant. DELARO COMPLETE is recommended to be used with a registered non-ionic surfactant, such as Agral 90 or AgSurf, at 0.125% vol/vol.

# SECTION 12: RESISTANCE MANAGEMENT RECOMMENDATIONS

For resistance management, please note that DELARO COMPLETE contains a Group 3, Group 11 and Group 7 fungicide. Any fungal population may contain individuals naturally resistant to DELARO COMPLETE and other Group 3, Group 11 and Group 7 fungicides. A gradual or total loss of pest control may occur over time if these fungicides are used repeatedly in the same fields. Other resistance mechanisms that are not linked to site of action, but specific for individual chemicals, such as enhanced metabolism, may also exist. Appropriate resistance-management strategies should be followed.

# To delay fungicide resistance:

- Where possible, rotate the use of DELARO COMPLETE or other Group 3, Group 11 and Group 7 fungicides with products from different fungicide groups that control the same pathogens.
- Do not apply more than the indicated maximum number of applications per year specified for each crop in the DIRECTIONS FOR USE, Section 8 table.
- Fungicide use should be based on an integrated disease management program that includes scouting, historical information related to pesticide use and crop rotation and considers host plant resistance, impact of environmental conditions on disease development, disease thresholds, as well as cultural, biological and other chemical control practices.
- Where possible, make use of predictive disease models to effectively time fungicide applications.
- Monitor treated fungal populations for resistance development. Notify Bayer if reduced sensitivity of the pathogen to DELARO COMPLETE is suspected.

- If disease continues to progress after treatment with this product, do not increase the use rate. Discontinue use of this product, and switch to another fungicide with a different target site of action, if available.
